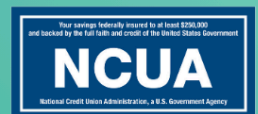

NEW ONLINE BANKING SECURITY FEATURE **COMING SOON**



The protection of your information is very important to us. We are pleased to announce an added login feature that helps guard your online information by adding another layer of identity verification to online financial interactions. The new security feature will be effective May 31, 2026.

How does the new security feature work?

When logging into online banking on your computer, you will receive a message (text or voice) on your phone with a 6-digit code. You will be asked to enter this code to complete the login process. This feature replaces answering security questions when logging in to online banking.

What do I need to do before May 31?

Please update your phone numbers in your online banking profile or in person with one of our tellers.

IMPORTANT! YOU WILL NOT BE ABLE TO ACCESS ONLINE BANKING IF WE DO NOT HAVE YOUR CORRECT CONTACT INFORMATION.

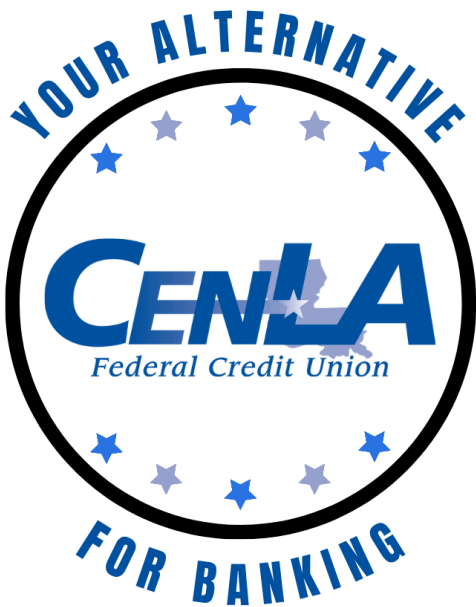

WHAT DOES CENLA FEDERAL CREDIT UNION DO WITH YOUR PERSONAL FINANCIAL INFORMATION?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history
- Credit history and credit score

When you are no longer our member, we continue to share your information as described in this notice.

How? All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's personal information; the reasons CenLA FCU chooses to share; and whether you can limit this sharing.

| How does CenLA FCU protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. |
| How does CenLA FCU collect my personal information? | We collect your personal information, for example, when you: <ul style="list-style-type: none"> • Open an account or deposit money • Pay your bills or apply for a loan • Use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. |
| Why can't I limit all sharing? | Federal law gives you the right to limit only: <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes - information about your creditworthiness • Affiliates from using your information to market you • Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. |
